## U.N. agency will expose Continua's Guidelines for plug-n-play healthcare technology to nations developing their healthcare infrastructure

However, this is not an area where we can afford to have costly squabbles over proprietary technologies. International standards for e-health are essential to overcome the interoperability problems that have been identified by the WHO. They will bring down costs, increase access, and improve efficiencies."

Continua will also participate in a number of ITU initiatives, including product demos, interaction with governments, regulators and industry leaders to share ideas and knowledge, and providing a voice for health information technologies on the global stage.
